Proposed development of a Greenway in Ballinrobe, Co. Mayo

Pursuant to the requirements of Section 179 of the Planning and Development Acts, 2000-2020 and Part 8 of the Planning and Development Regulations 2001-2020, notice is hereby given that Mayo County Council proposes to carry out a development, particulars of which are set out in the Schedule hereunder.

Townlands of Friarsquarter West, Cornaroya & Knockfereen, Ballinrobe, Co. Mayo	<p>The construction of a greenway as a cycle and pedestrian route along the eastern outskirts of Ballinrobe Town, in the townlands of Friarsquarter West, Cornaroya and Knockfereen.</p> <p>The proposed greenway is 909m in length and will comprise of three sections:</p> <ol style="list-style-type: none">1) From the Primary Care Centre/Slí na Róba Housing Est. on the R331 to the L1611 Convent Road2) From the National School on Convent Road to the L16111 Cornaroya road3) From Cornaroya Road to the L16173 Station Road <p>The proposal includes pavement construction, fencing, boundary treatments, and erection of Footbridge over the Bulkan River.</p>
