Proposed Public Realm Improvement works at Medlicott Street Newport Co Mayo

Pursuant to the requirements of Section 179 of the Planning and Development Acts, 2000-2020 and Part 8 of the Planning and Development Regulations 2001-2020, notice is hereby given that Mayo County Council proposes to carry out a development, particulars of which are set out in the Schedule hereunder.

Location	Nature and Extent of Development	
Medlicott Street , Newport, Co Mayo	Works consist of a series of measures to improve both the safety and quality of the public realm on Medlicott Street. Measures include the provision of; Traffic calming, off road cycle lanes, accessible designated parking spaces, pedestrian crossings, clear delineation of roadway and parking spaces, widened and repaved footpaths and landscaped public spaces.
