## NATURE & EXTENT OF PROPOSED

Segregated footpaths and one way cycle facilities on both sides of the N60 within the 60km/h zone. shared pedestrian/cycle facilities corridor on one side of the N60 in the 80 km/h and 100km/h zones, provision of a periodic 60km/h zone at Breaffy primary school, removal of the hard shoulder at Breaffy village, provision of new jug handle crossing, 3 new cycle and pedestrian crossings, 2 new bus bays at Breaffy village and upgrade of Kilkenny Cross Roundabout to accommodate active travel provisions, total scheme length 4.2km
