## Proposed development of 6 no. dwellings, together with all associated site development works at Mount Street, Claremorris, Co. Mayo.

Pursuant to the requirements of Section 179 of the Planning and Development Acts, 2000-2020 and Part 8 of the Planning and Development Regulations 2001-2020, notice is hereby given that Mayo County Council proposes to carry out a development, particulars of which are set out in the Schedule hereunder.

## Schedule

Location	Nature and Extent of Development
Mount Street, Claremorris, Co. Mayo.	The construction of 6 no. new dwellings comprising 2 No. 1 bed houses and 4 No. 2 bed apartments together with all associated site development works including access archway, open landscaped courtyard, site boundaries, drainage, associated earthworks, public lighting, utilities and services connections and all ancillary site works.  All dwellings will be provided with private gardens or outdoor terraces.
