Planning and Development Acts 2000 – 2020 Planning and Development Regulations 2001-2020

Proposed development of 3 no. dwellings, together with all associated site development works at Manor Gardens, Church Manor, Ballina, Co. Mayo.

Pursuant to the requirements of Section 179 of the Planning and Development Acts, 2000-2020 and Part 8 of the Planning and Development Regulations 2001-2020, notice is hereby given that Mayo County Council proposes to carry out a development, particulars of which are set out in the Schedule hereunder.

Location	Nature and Extent of Development
Manor Gardens, Church Manor, Ballina, Co. Mayo.	The construction of 3 no. new dwellings comprising 1 No. 3 bed detached house, and 2 No. 3 bed houses in a semi-detached block. All associated site development works including footways, site boundaries, drainage, landscaping, associated earthworks, public lighting, utilities and services connections, diversions of existing services and all ancillary site works. All dwellings will be provided with private gardens, and associated car parking.
