It would only take a few minutes for buses to go into Kilkelly, even on the grounds of safety.

Knock and Cong were also identified as areas needing shelters by Councillor Damien Ryan given the volume of visitors to both.

Members were told a submission is being prepared for Kilkelly. Ballinrobe, Ballindine and Knock are also identified for upgrading.

The point was also made that getting agreement on bus shelter locations can be difficult. Everyone wants them a health and safety matter, but not outside their door.
