PROPOSED DEVELOPMENT: BALLINA FLOOD RELIEF SCHEME

Pursuant to Section 175 and 177AE of the Planning and Development Act 2000 (as amended), and as set out in Article 121 of the Planning and Development Regulations 2001-2024 (as amended), formal notice is hereby given that Mayo County Council (MCC) has made a planning application for approval to An Bord Pleanála to carry out the proposed Ballina Flood Relief Scheme.

The proposed Ballina Flood Relief Scheme will consist of flood relief works along and/or adjacent to and/or in the vicinity of the River Moy and the following tributaries: Quignamanger Stream, Bunree (Behy Road) Stream, Brusna River and the Tullyegan Stream in the townlands of Ballina, Quignamanger, Quignalecka, Quignashee, Knocknalyre or Downhill, Ballyholan, Abbeyhalfquarter, Rathkip, Ardnaree or Shanaghy, Carrowcushlaun West, Mullauns, Commons, Behybaun and Rahans, County Mayo.

A Natura Impact Statement (NIS) and an Environmental Impact Assessment Report (EIAR) have been prepared for the proposed development.

Submissions / Observations

Submissions or observations may be made before 17:30 hours on 9th June, 2025, in writing, to An Bord Pleanála, 64 Marlborough Street, Dublin 1, D01 V0902, in respect of:

- i. The implications of the proposed development dealing with the proper planning and development of the area in which the development is concerned,

- iii. The likely significant effects of the proposed development on a European Site, if carried out.
